Radio ‘Izzlam’ & “SANHA” Members’ Trip To Middelburg

Just a few weeks ago, Middelburg became ‘famous’ by few audio clips that emerged from there which were laden with vulgarity, abuse, threats and even racism. The abuse in those voice notes which were directed to Masjid Staff who are from Malawi, have thus far been swept under the rug. Apart from a damage-control statement issued from the Masjid, there is nothing else that has emerged, to the best of our knowledge. The issue of racism which the clips contained, is left unattended by the so-called ‘scholars’ of Middelburg.

Remember, Middelburg houses a JUSA office – *albeit this organisation being a modernist group preparing the stage for Dajjaal* – and also has the secretary of UUCSA residing therein – *UUCSA, the anti-Masjid mob and friends of the court*. Yet, their silence on this racism is indeed deafening! Their silence on this critical issue which directly affects their Masjid, the Musallis and the staff directly, is indeed unfortunate. After all, during the covid-circus in which many opted to be turned into clowns with the enforcing of the silly protocols, Middelburg’s scholars showed one and all which side their bread is buttered – *the side of the insane atheists’ protocols of clownery*. Thus, their anti-Sunnah protocols and enforcing it diligently in their Masjid, perhaps has resulted in their procrastinating and even ignoring totally this critical issue affecting the Masjid staff. After all, it is the Masjid staff affected, the same Places in which Middelburg scholars enforced alien-to-Sunnah protocols of gentlemen who belie the existence of Allah Rabbul Izzat!

Every Muslim knows the importance of the Jumu’ah platform. Education related to Islam is propagated from the Jumu’ah Bayaan. Also, critical town related issues should be discussed from the Jumu’ah Bayaan.

Despite seizing any such opportunity to tackle racism and to clear the matters, to bring some sort of delight to the grieved and bereaved hearts of the *Bichara* Malawi Masjid staff, the so-called ‘scholars’ allowed the bulldozers of the Shari’ah (Radio Izzlam) and those who have caused a havoc and racket in the Muslim’s consumption (SANHA), to grace the Masjid’s Jumu’ah platform!

Yes, SANHA's director and CEO and Radio Izzlam's scholars who are known for modernism, among other un-Islamic things, headed to Middelburg. Alas! The unfortunate fact is that Middelburg has modern-type scholars who are the 'leaders' in their community. Therefore, due to such leaders, the subjects are exposed to modernism and liberalism, Baatil and Dhalaal. The Musallis are exposed to the Baatil version of Islam which is the watering away of the Original Shari'ah into the gutters and sewage of modernism, interfaith, etc., in Middelburg, unfortunately! This truth and fact, stuns the people guilty of approving stunned meat! It also stuns the consumers who have become accustomed to stunned meat!

Daily, on a wholesale basis, SANHA certifies animals which are stunned prior to slaughter. Of those animals, which ones actually die and which ones are alive when slaughtering? Can SANHA tell us? Can the consumer who trusts SANHA tell us if the particular meat he/she buys or eats is that of the animal which didn't die during the un-Islamic and anti-Sunnah stunning which causes great Takleef to the animals?

What program could SANHA's Molvi Navlakhi have hosted regarding 'The Halaal Industry' as per the poster in Middelburg, despite his organisation being doubtful on the very basic Principles related to Islamic Zabah? Basically, his SANHA approves the 'slaughter', or mock-slaughter of some or many already DEAD animals due to being stunned and dying just seconds before that. Is this what a Muslim does? He slaughters carrion with **Bismillah-Allahu-Akbar** and then certifies it as 'Halaal', thereby directly opposing and challenging Allah's Laws declaring carrion as Haraam in the Qur'an Majeed? Yes, the 'Halaal Industry' is, as warned by Ulama, a 'money-making industry'! **Innalillahu-wa-inna-ilaihi-raaji'oon!** What blatant mockery is this not!!!

TAKE THE FOLLOWING EXAMPLE: A policeman, dressed in his duty uniform, explains to the community members of the evil of theft and the fines or jail sentences a thief who is caught may face. Yet, this police officer is himself a criminal! And some lawyers and policemen have already exposed this particular police officer. Will the community heed such an officer's advice? Thus, a scholar representing a so-called

‘Halaal’ body, and was scheduled to discuss the Halaal industry, yet his very same organisation is feeding the Ummah doubtful meat. And to top it, Ulama-e-Haq have factually exposed his organisation with evidence. Pork spices, etc. with his company’s ‘Halaal’ labels have been discovered several times by innocent Muslim shoppers. Haraam commercial chickens at chicken abattoirs have been also factually exposed in the past by Ulama-e-Haq. And now today, SANHA’s CEO discusses the ‘Halaal’ Industry. What a contradiction!
